Guidelines and Requirements



Theme

The Snowflake Art Show began in 1990 to promote art in Rocklin. The name was chosen to convey the message that art is like the snowflake, where no piece of art is the same. Each has a uniqueness all its own.

Eligibility

All 2 dimensional and 3 dimensional fine arts. NO CRAFT ITEMS. All original artwork must be ready for display. Does not have to be recent work. There is no specific theme for the artwork. Snowflake Art Show is a juried show. Original art work only.

Categories

Adult artwork are judged by medium: oil, photography, acrylics, pastels, watercolor, pen/pencil/charcoal, sculpture, and mixed media. Student Art will be judged by age categories.

Fee

A non-refundable \$10.00 fee is required for each entry. (No fee for students.)

You may only submit 2 entries per artist. Show is limited to 80 pieces of adult work.

Deadline/Entry Delivery

Deadline for entries is Wednesday, February 3. Entries must be delivered to Finn Hall, 4090 Rocklin Road on Wednesday, February 10, 8am-noon or 5-7pm.

Responsibility

The City of Rocklin, will not be held responsible for loss or damage to artwork or frame. A signed release/waiver is required at time of delivery of artwork. Any artist under the age of 18 must have parent/guardian sign release/waiver.

Viewing

Saturday, February 13 & Sunday, February 14 from 11:00am - 5:00pm

Reception

Opening reception will be held Friday, February 12, from 7-9pm at Finn Hall. Artists are encouraged to invite family and friends to the opening reception for awards presentations and an informal gathering.

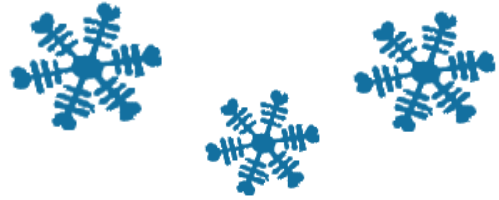

Participant Waiver, Release, Assumption of Risk and Indemnity Agreement

This form is a contract with legal consequences. Read carefully before signing.

In consideration for being permitted by the City of Rocklin to participate in the above activity(ies), I hereby waive, release and discharge any and all claims for damages for personal injury, death, or property damage which I or my child (if participating) may have, or which hereafter accrue to me, or my child, against the city as a result of my or my child's participation in the activity(ies). This release is intended to discharge the city, its officers, officials, employees and volunteers, and any other involved public agencies from and against any and all liability arising out of or connected in any way with my or my child's participation in the activity, even though that liability may arise out of the negligence or carelessness on the part of the persons or public agencies mentioned above. I further understand that accidents and injuries can arise out of the activity(ies); knowing the risks, nevertheless, I hereby agree to assume those risks and to release and to hold harmless all of the persons or agencies mentioned above who (through negligence or carelessness) might otherwise be liable to me, or my child (or my or my child's heirs or assigns) for damages. It is further understood and agreed that this waiver, release and assumption of risk is to be binding on my and my child's heirs and assigns. In addition, I agree to indemnify and hold harmless city and its officers, officials, employees and volunteers from and against all claims, damages, losses and expenses including attorney fees arising out my or my child's participation in the activity(ies) described above, caused in whole or in part by my or my child's negligent act, except where caused by the active negligence, sole negligence, or willful misconduct of the city.

Participant Photograph Release

I hereby grant to the City of Rocklin the absolute and irrevocable right and permission to use, reuse, and publish all pictures of me or my child taken in the course of City of Rocklin business. I fully understand that I hold no control over the use of the photograph(s) of which I or my child is a part. Further, I grant to the City of Rocklin, and those who the city may represent, the right to use my name or my child's name. I hereby release the City of Rocklin from any and all claims and demands arising out of, or in connection with, the use of the photograph(s), including any claims of libel. This authorization and release shall also apply to those working with, or in connection with, the City of Rocklin, as well as the person(s) who took the photograph(s). I have fully read the foregoing and completely understand the contents.

I HAVE CAREFULLY READ THE ABOVE RELEASE & INDEMNITY AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND AGREEMENT TO INDEMNIFY THE CITY AND I SIGN IT OF MY OWN FREE WILL.

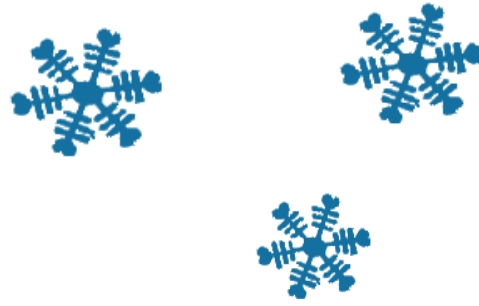
