Dear Mr. Fu:

After careful consideration, please accept this letter as notice that Universal Health Services "UHS" is withdrawing its pending application. While concerns have been raised by the Rocklin community about the patient population we serve, UHS's experience at more than 200 behavioral hospitals around the country demonstrates that these concerns are not based upon facts. This application is not being withdrawn because of alleged risk factors to the public. Characterizing our patients as violent and sex offenders is false and misleading. This misrepresentation only serves to further the stigma of mental illness and promote discrimination against this vulnerable population. Those in need of acute psychiatric care – veterans, neighbors, children, siblings, parents – need and deserve better.

To date, the one point on which all parties agree is that there is a need for behavioral health services in the community. UHS is evaluating alternative locations inside and outside of Rocklin where these services can be provided. In considering alternative Rocklin locations, my client is reviewing the recommendations of the Police Chief for feasibility, demonstrated need and compliance with state and federal law. Notwithstanding the public's general perception, this type of hospital has been successfully located and operated in all kinds of neighborhoods across the county, including those in close proximity to schools and parks. The UHS proposal faces special conditions in Rocklin unprecedented by any other local government despite the reality that other Rocklin medical professionals are likely treating individuals with psychiatric disorders without such limitations or requirements. If my client proceeds with a hospital in Rocklin, its looks forward to a fact driven evaluation and fair treatment of its application.
