Request for approval of a Conditional Use Permit and Design Review to construct a 4,505 square foot vehicle service facility and site improvements on 0.64 acre. Operations would consist of oil changes and other light vehicle services.

The project site is located on the south side of Stanford Ranch Road, approximately 500 feet southwest of the intersection of Stanford Ranch Road and Sunset Boulevard. APN 017-460-001.

The property is designated Retail Commercial (RC) in the Rocklin General Plan and is zoned Planned Development Commercial (PD-C) in the Stanford Ranch General Development Plan.

A preliminary review of this project pursuant to the California Environmental Quality Act (CEQA) has tentatively identified a Notice of Exemption as the appropriate level of review for this project.
