## PUBLIC HEARING NOTICE

**NOTICE IS HEREBY GIVEN** that the **Planning Commission** of the City of Rocklin will hold a public hearing at the Rocklin Event Center, 2650 Sunset Boulevard, Rocklin, beginning at **6:30 p.m.** on **Tuesday, May 19, 2020** to consider the following:

## RE: PLACER ACADEMY EXPANSION CONDITIONAL USE PERMIT, U2019-0004 (Temporary Use Permit, BZ2017-02)

This application is a request for approval of a Conditional Use Permit to allow for the permanent operation of a charter school for transitional kindergarten through 8<sup>th</sup> grade classes totaling up to 456 students in a retail commercial shopping center. The school would occupy two adjacent buildings (approximately 24,000 total square feet) with administrative offices to be located in a separate suite within the same center. A 13,000 square foot area of the existing parking lot is proposed to be converted to an outdoor play yard, requiring the primary existing north-south access aisle within the shopping center to be gated during student outdoor times (M-F 9:30 AM to 1:30 PM). No modifications to the existing building exteriors have been proposed. The school had previously been permitted to operate a small campus on a portion of the on a temporary basis however that permit (BZ2017-02) has expired and is no longer valid.

The subject site is located within existing buildings at 3031, 3051, & 3071 Stanford Ranch Road, in the eastern portion of the Save Mart shopping center at the intersection of Stanford Ranch Road and Park Drive. APNs 367-160-007, -011, and -012.

The property is designated Business Professional/Commercial/Light Industrial (BP/COMM/LI) in the Rocklin General Plan and is zoned Planned Development Business Professional/Commercial (PD-BP/C) in the Stanford Ranch General Development Plan.

A review of this project pursuant to the California Environmental Quality Act (CEQA) has identified a Categorical Exemption as the appropriate level of environmental review for this project.

The applicant is Placer Academy and the owner is JJD-HOV Rocklin, LLC.

E-mail comments received during the public hearing are subject to the same rules that apply to speaker comments at the meeting: they must be received prior to the close of the public hearing and the reading of each comment is limited to no more than five minutes.
