PUBLIC HEARING NOTICE

NOTICE IS HEREBY GIVEN that the **PLANNING COMMISSION** of the City of Rocklin will hold a public hearing in the **COUNCIL CHAMBERS** at the Rocklin City Hall, 3970 Rocklin Road, beginning at **6:30 p.m.** on **TUESDAY, AUGUST 17, 2021** to consider the following:

RE: PASQUETTI ENGINEERING HEADQUARTERS DESIGN REVIEW, DR2019-0013

This application is a request for approval of a Design Review to allow the construction of a new company headquarters comprised of a main office (7,879 square feet), a warehouse/office building (8,359 square feet), a shop/office building (9,326 square feet), , two open equipment sheds (3,600 square feet and 4,300 square feet), a pad for a future warehouse/office building, paved and gravel yard areas, including truck and equipment storage and parking, employee and visitor parking, and associated site improvements, landscaping, and appropriate hardscape. (Square footages are approximate.)

The subject site is located at 4080 Del Mar Avenue. APNs 045-011-013 and 045-011-014.

The property is zoned Planned Development Light Industrial (PD-LI). The General Plan designation is Light Industrial (LI).

Notice is hereby given that the City of Rocklin will consider adoption of a Mitigated Negative Declaration for the development project described above. The review period for the Mitigated Negative Declaration begins on July 16, 2021 and ends at 5:00 p.m. August 16, 2021. The environmental document is available for review during normal business hours at the City of Rocklin Community Development Department, Planning Division, located at 3970 Rocklin Road, Rocklin, CA 95677 and online at http://www.rocklin.ca.us/depts/develop/planning/currentenvirondocs.asp.
