PUBLIC HEARING NOTICE

NOTICE IS HEREBY GIVEN that the **Planning Commission** of the City of Rocklin will hold a public hearing in the Council Chambers at the Rocklin City Hall, 3970 Rocklin Road, Rocklin, beginning at **6:30 p.m.** on **Tuesday, October 16, 2018** to consider the following:

RE: BLUE OAKS MARKETPLACE (ROCKLIN WEST)
TENTATIVE PARCEL MAP, DL2018-0003

This application is a request for approval of a Tentative Parcel map to re-subdivide an existing approximately 12.15 acre shopping center into seven separate parcels.

The subject site is located on the northeast corner of Lonetree Boulevard and Blue Oaks Boulevard. APN 365-020-048 and 365-020-049.

The property is zoned Planned Development Commercial (PD- C). The General Plan designation is Retail Commercial (RC).

A Mitigated Negative Declaration of Environmental Impacts was previously approved by the Rocklin Planning Commission through Resolution No. PC-2002-53. The requested tentative parcel map does not result in any environmental impacts beyond those that were previously identified and therefore, the tentative parcel map can rely on the approved Mitigated Negative Declaration.

The applicant and property owner is Ruchika Sidhu with Timber Soma Blue Oaks, LP.
