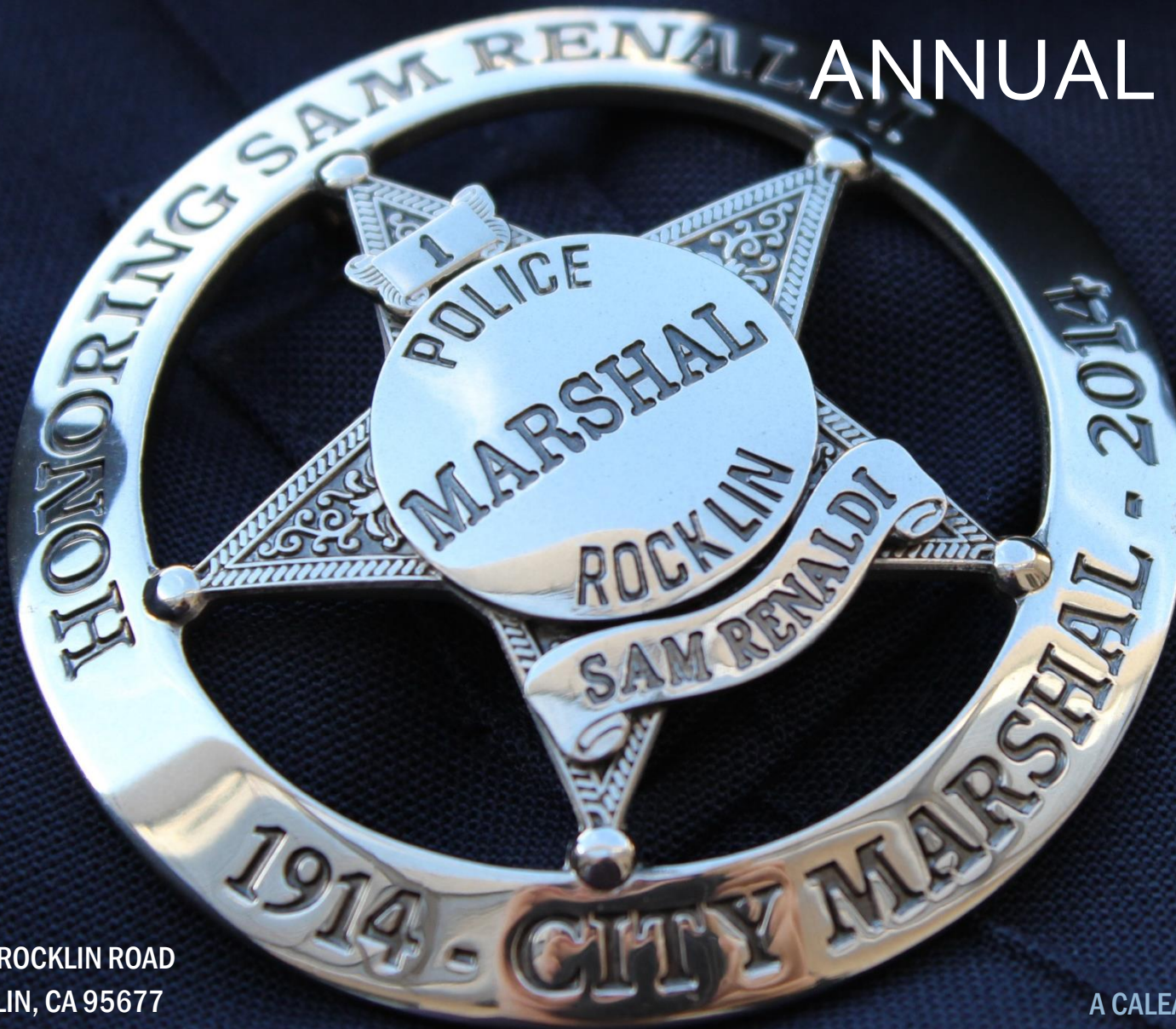

Rocklin Police Department Message from the Chief



February 19, 2014, commemorated the 100-year anniversary of our first Rocklin police officer killed in the line of duty. In a story that remarkably resembles that of the 1881 shootout in Tombstone, Arizona, at the OK Corral with Marshal Wyatt Earp and his deputies against the notorious "Cowboys" outlaw gang, Rocklin's first officer killed in the line of duty has an equally dramatic history.

In early February, 1914, Rocklin City Marshal Sam Renaldi had issued a citation to a saloon owner on Railroad Avenue for saloon curfew violations and for leaving beer kegs blocking the sidewalk. The saloon owner would become enraged by this and swore to get revenge. On February 18, 1914, the saloon owner, who had been drinking all day, confronted Marshal Renaldi at a stable near Rocklin Road and Pacific. The saloon owner, drunk and armed with a pistol, began yelling at the Marshal but was detained by a deputy. The drunken saloon owner suddenly drew his pistol and shot the Marshal, who returned fire with his service revolver. Both men slumped to the ground with mortal bullet wounds and were transported to a Sacramento hospital the following day on February 19, 1914, where they both died from gunshot injuries. Both were later buried in the Rocklin Cemetery.

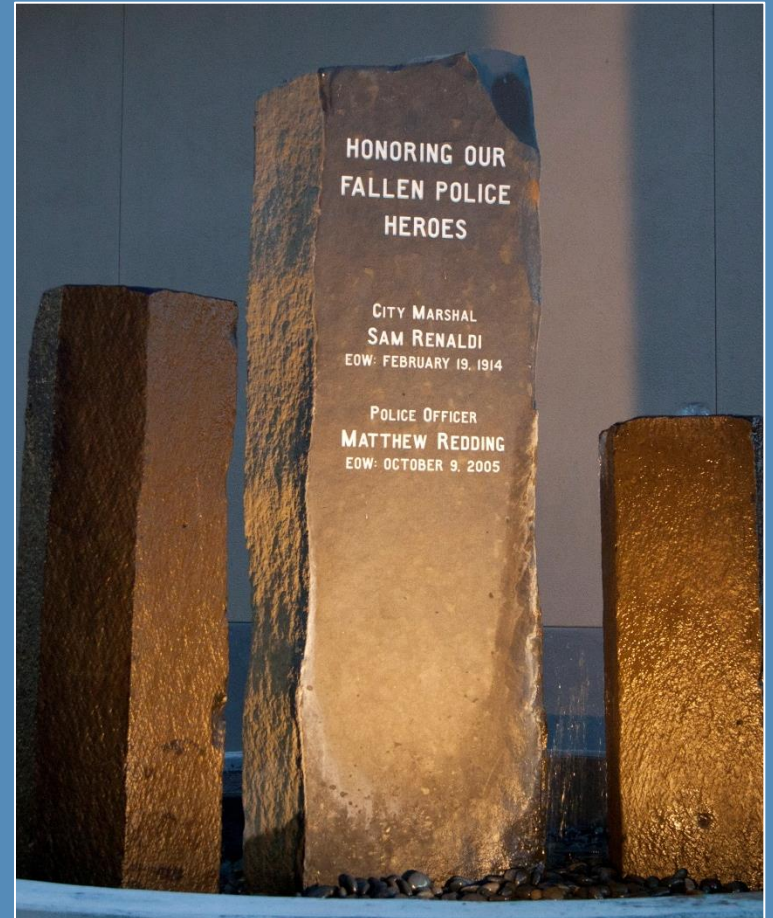
100 years later, at a large public ceremony on February 19, 2014, the Rocklin Police Department unveiled our Police Memorial located at the front of our facility, honoring both City Marshal Sam Renaldi, as well as our second police officer killed in the line of duty, Police Officer Matt Redding who died on October 9, 2005, after being struck by a DUI driver. Between February 19, 2014 and February 19, 2015, members of the Rocklin Police Department were authorized to purchase and wear a special-edition badge that replicated those worn by our early Rocklin City Marshals, in memory of Marshal Renaldi.

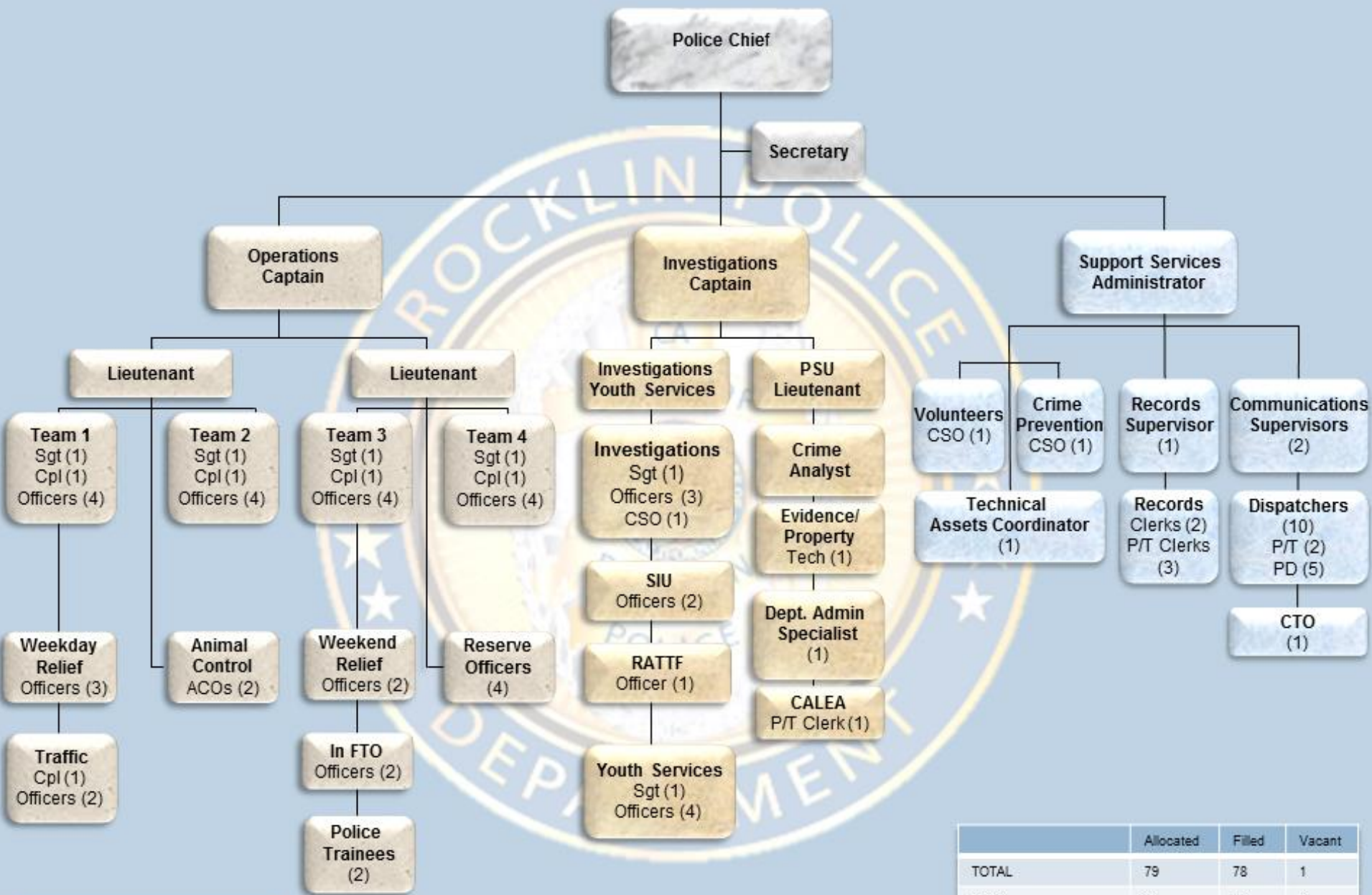

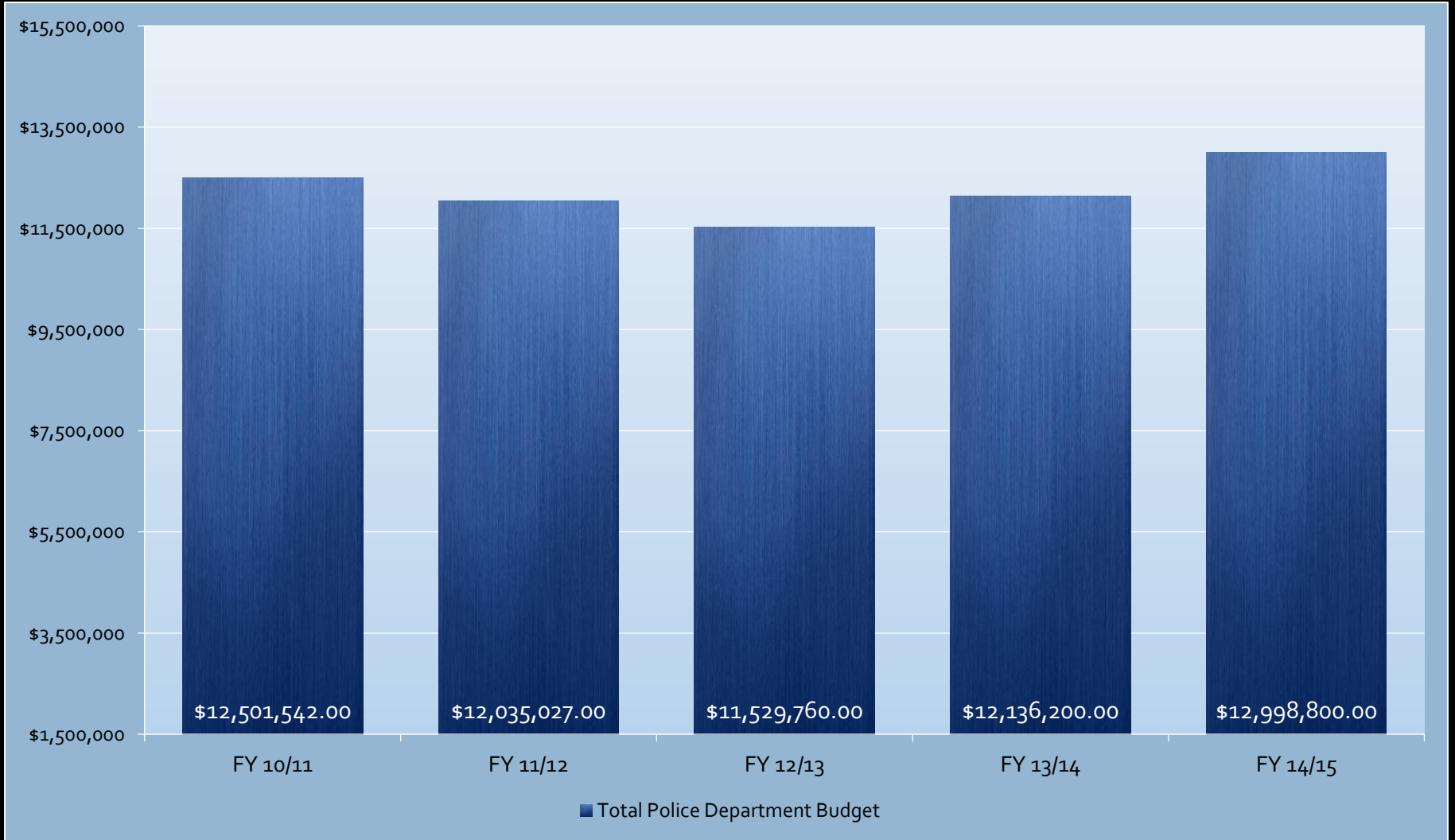




Team 1 – Weekday Dayshift

Team 4 – Weekend Graveyard

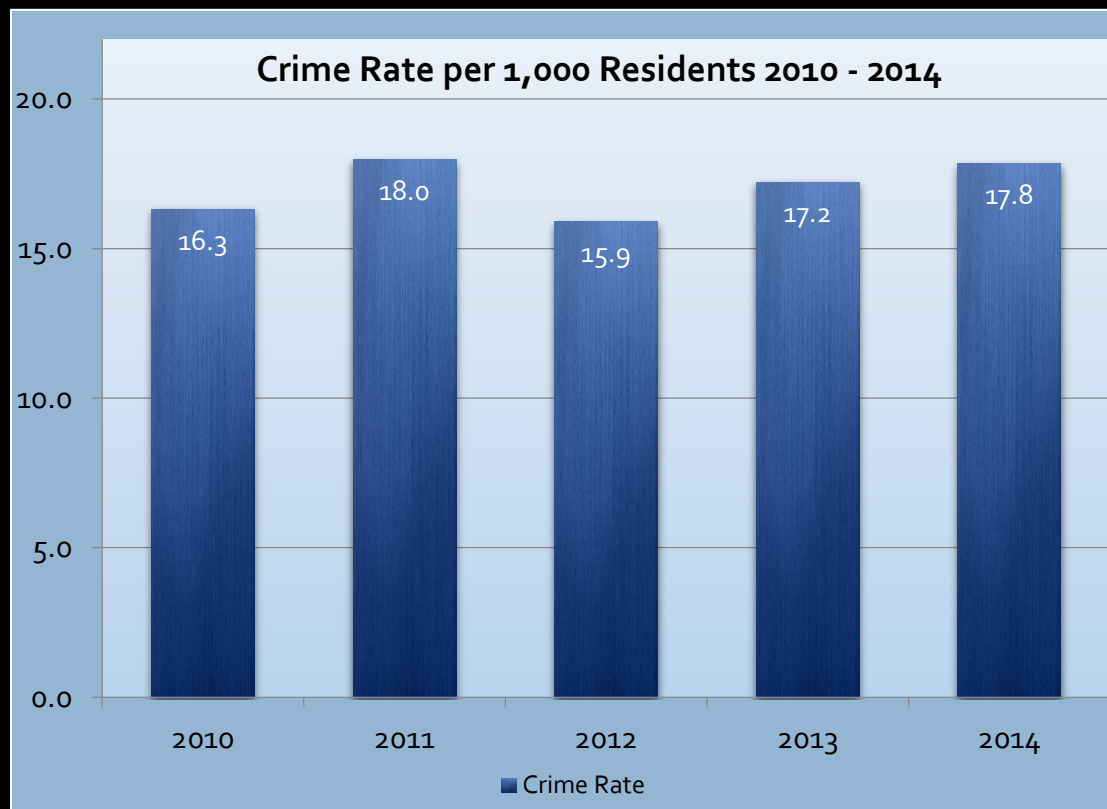

In 2014, 839 citations were issued for speeding and 486 citations were issued for cell phone violations.



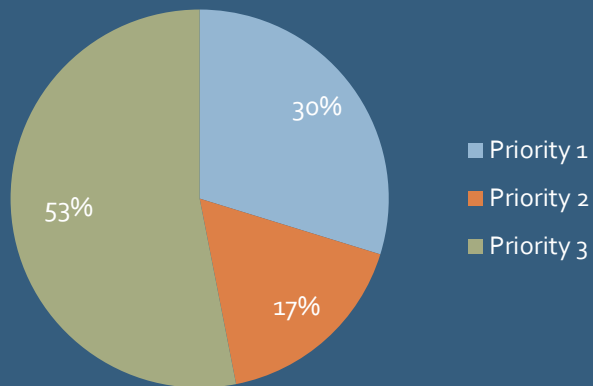

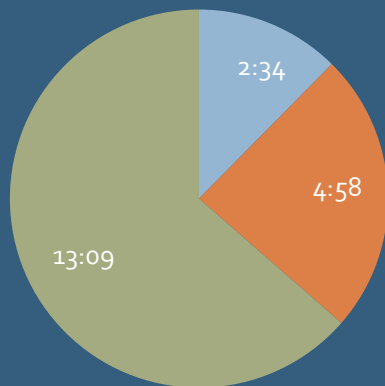

Call Type by Priority

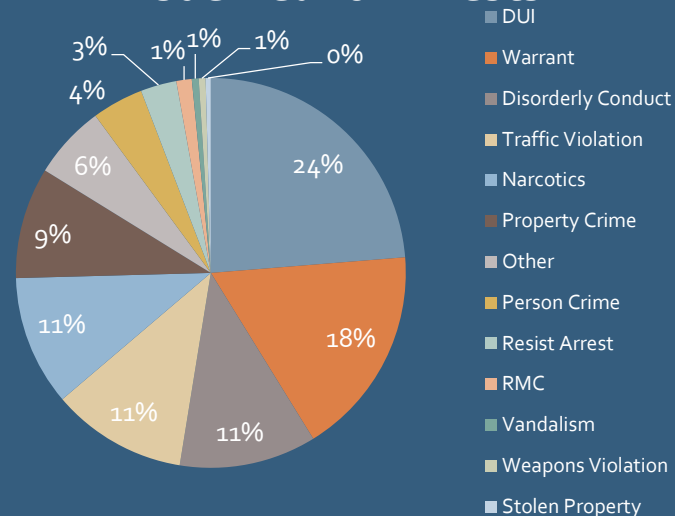


Priority 1 – Emergency situations requiring immediate police response

 Priority 3 – Non-emergency and report incidents that do not require an emergency response

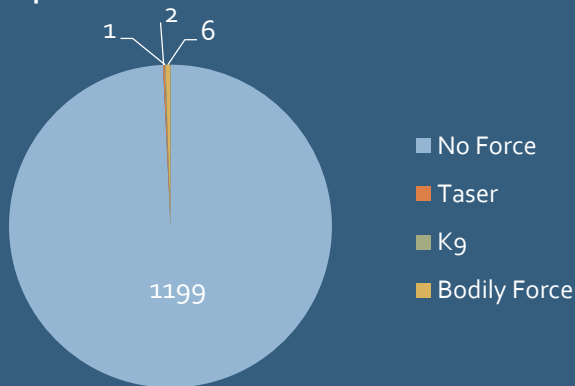
Time Call Received to Dispatched



Misdemeanor Arrests

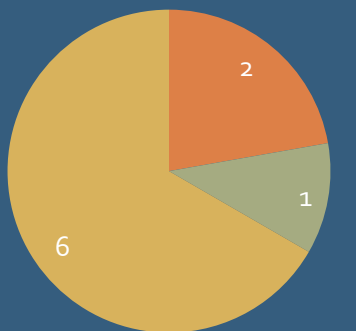


Response to Resistance Arrests

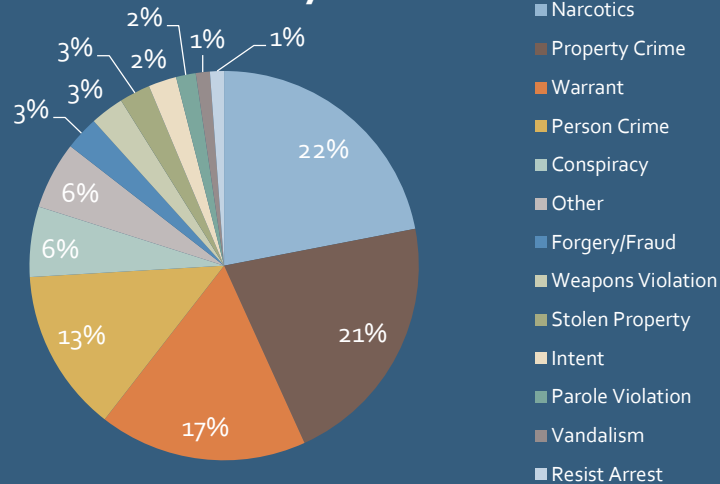


Officers used a Response to Resistance when making an arrest only 9 times during 2014, which is less than 1% of the total 1208 arrests made. Of the times Response to Resistance was used, a Taser was used .17%, K9 .08%, bodily force .50%, pepper spray 0%, baton 0%, and deadly force/firearm 0%

Professional Standards Complaints & Commendations

There are 509 local law enforcement agencies in California. Rocklin is one of only 15 accredited agencies in California and among only 5% in the entire nation.

PROFESSIONAL STANDARDS

The Professional Standards Unit (PSU) is responsible for protecting the integrity and reputation of the police department. The PSU's duties range from managing the agency's accreditation process, to overseeing the complaint and commendation process of police personnel.

The Rocklin Police Department has been a nationally accredited agency for the past seven years. Accreditation is awarded by the Commission on Accreditation of Law Enforcement Agencies (CALEA). Rocklin PD participates in this voluntary process to pursue excellence, and to ensure the highest law enforcement standards are maintained.

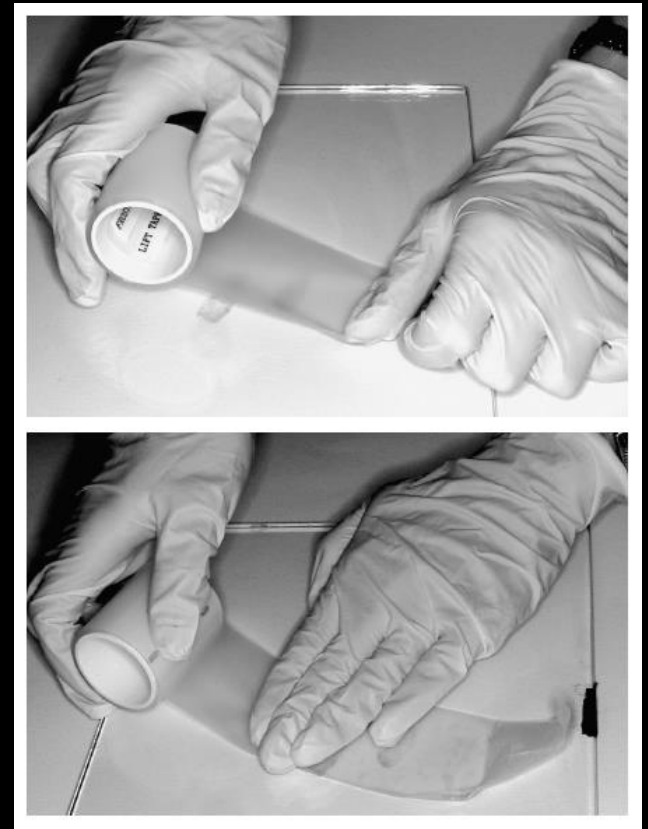
12 formal complaints represent .022% of the total number of police incidents for 2014. That equates to 1 complaint for every 4,481 calls.
