RE: CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER) FOR PROGRAM YEAR 2018 (2018-2019)

Project Description:

In accordance with a requirement of the federally-funded Community Development Block Grant (CDBG) program, city staff has prepared the annual CAPER. The CAPER contains information on performance and program accomplishments during the 2018-2019 CDBG program year. The report provides information regarding the City's expenditure of federal CDBG funds; specially addressing progress made by the City towards completion of public service activities and accessibility projects. The 2018 CAPER has been completed in compliance with federal program regulations and the City's Citizen Participation Plan. The current CAPER covers the period from July 1, 2018 through June 30, 2019 and is available for review and comment.

Public Review and Comment:

The public review period for this document is from August 16th to September 2nd. During this time, the public is invited to comment.
