



PUBLIC HEARING NOTICE

NOTICE IS HEREBY GIVEN that the **PLANNING COMMISSION** of the City of Rocklin will hold a public hearing in the **COUNCIL CHAMBERS** at **ROCKLIN CITY HALL**, 3970 Rocklin Road, beginning at **6:00 p.m.** on **TUESDAY, JANUARY 20, 2026** to consider the following:

**RE: RIVIAN 24 HOUR SERVICE CENTER
CONDITIONAL USE PERMIT, U2025-0006
ENVIRONMENTAL, ENV2025-0017**

The application is a request for a Conditional Use Permit to operate a 24 hour/7 days per week Automotive Repair Center within an existing approximately 39,000-square-foot commercial building. The proposed use would occupy approximately 20,000 square feet of service area and include six service bays, with the remaining space dedicated to administrative and support functions.

The Project site is an approximately 3.17-acre commercial parcel at the intersection of Granite Drive and Dominguez Road. The Assessor's Parcel Number (APN) is 045-021-036-000.

The property is designated Retail Commercial (RC) in the Rocklin General Plan. The property is zoned Planned Development Commercial (PD-C) within the Automotive Overlay (AO) zone.

A review of this project pursuant to the California Environmental Quality Act (CEQA) Section 15301 Existing Facilities has been conducted and has identified a Categorical Exemption as the appropriate level of environmental review for this project.

The property owner is Victor Guidera Trust / Guidera Family Properties Inc. The applicant is Rivian Automotive c/o Jamie Vassallo (Rivian) and Orest Kravets (agent).
