## PUBLIC HEARING NOTICE

**NOTICE IS HEREBY GIVEN** that the **CITY COUNCIL** of the City of Rocklin will hold a public hearing in the **COUNCIL CHAMBERS** at **Rocklin City Hall**, 3970 Rocklin Road, beginning at **6:00 p.m.** on **TUESDAY**, **APRIL 11**, **2023** to consider the following:

RE: STREET NAME CHANGE CHEETAH STREET (PORTION) TO OCELOT WAY STREET NAME CHANGE, SNC2023-0001 ENVIRONMENTAL, ENV2023-0002

This application is a request for approval of a street name change to re-name of a portion of Cheetah Street, a street linking Whitney Ranch Parkway to the Wildcat Subdivision (the point at which Cheetah Street makes a sharp left turn to the east), to "Ocelot Way". The name of the remaining portions of the street will not be changed.

The subject street section begins at the intersection of Cheetah Street and Whitney Ranch Parkway and extends south to the point at which Cheetah Street makes a sharp left turn to the east. Bounded by APNs 017-171-039 & 043, 491-031-023, and 491-032-040.

Notice is hereby given that the City of Rocklin intends to adopt a Categorical Exemption, pursuant to the California Environmental Quality Act (CEQA) Section 15301 Existing Facilities, as the appropriate level of environmental review for this project.

The project site is not on any of the lists enumerated under Section 65962.5 of the Government Code related to hazardous waste.

The applicant and property owner is the City of Rocklin.

The Planning Commission reviewed this item on February 21, 2023 and voted 4-0 (one commissioner absent) to recommend City Council approval of the project.
