PUBLIC HEARING NOTICE

NOTICE IS HEREBY GIVEN that the **COMMUNITY DEVELOPMENT DIRECTOR** of the City of Rocklin will hold a public hearing in the **COUNCIL CHAMBERS at Rocklin City Hall**, 3970 Rocklin Road, beginning at **9:00 a.m.** on **TUESDAY, JANUARY 27, 2026**, to consider the following:

**RE: ANIMAL EYE CENTER – PACIFIC STREET
CONDITIONAL USE PERMIT AND DESIGN REVIEW/BARRO ZONE, BZ2025-0001
ENVIRONMENTAL, ENV2025-0015**

The application is a request for a Design Review and Conditional Use Permit to convert an existing automotive building into a Veterinary Facility project pursuant to the Business Attraction, Retention, and Revitalization (BARRO) Overlay Zone.

The proposed project involves converting an existing 6,049-square-foot commercial automotive building into an Veterinary Facility. The project includes the addition of eight new parking spaces and modifications to the front façade (west elevation). The Animal Eye Center will operate from 8:00 a.m. to 5:00 p.m. on weekdays and will provide after-hours emergency care. The facility will be staffed by up to six employees at a time and is expected to serve up to 15 clients per day. No overnight care will be provided.

The project site is a 0.83±acre commercial property located at 5880 Pacific Street, which is northwest of the intersection of Sunset Boulevard and Pacific Street. The Assessor's Parcel Number (APN) is 010-191-064.

The property is designated Retail commercial (RC) in the Rocklin General Plan. The property is zoned Retail Business (C-2) within the Business Attraction, Retention, and Revitalization Overly (BARRO) zone.

A review of this project pursuant to the California Environmental Quality Act (CEQA) Section 15301 Existing Facilities has been conducted and has identified a Categorical Exemption as the appropriate level of environmental review for this project.

The property owner is Sydney Edwards. The applicant is Wells Construction Inc. c/o Katherine Orloff.
