PUBLIC HEARING NOTICE

NOTICE IS HEREBY GIVEN that the **PLANNING COMMISSION** of the City of Rocklin will hold a public hearing in the **COUNCIL CHAMBERS at Rocklin City Hall**, 3970 Rocklin Road, beginning at **6:30 p.m.** on **TUESDAY, APRIL 2, 2024** to consider the following:

The project is a request for approval of a Design Review and Conditional Use Permit to allow the construction of a convenience store 3,349 square feet in size, a 300 square foot carwash, and a 4,500 square foot fuel canopy with two underground storage tanks. Site improvements also include additional on-site parking, vacuum stalls, landscaping and appropriate hardscape.

The project site is located at the southwest corner of Whitney Ranch Parkway & Ocelot Way (APN 017-171-039).

The property is zoned Planned Development Commercial (PD-C). The General Plan designation is Mixed Use (MU).

Notice is hereby given that the City of Rocklin will consider adoption of a Mitigated Negative Declaration for the development project described above. The review period for the Mitigated Negative Declaration begins on March 9, 2024 and ends at 5:00 p.m. March 28, 2024. The environmental document is available for review during normal business hours at the City of Rocklin Community Development Department, Planning Division, located at 3970 Rocklin Road, Rocklin, CA 95677 and online at http://www.rocklin.ca.us/depts/develop/planning/currentenvirondocs.asp. The applicant is Linda Petroleum, Inc. The property owner is Oakwood Trails 7V LLC.
