REVIEW PERIOD: December 14, 2017 – January 16, 2018

The City of Rocklin as the Lead Agency is announcing the availability of the Draft Mitigated Negative Declaration for the Croftwood II Subdivision Project. The review period for the Mitigated Negative Declaration begins on December 14, 2017 and ends at 5:00 p.m. on January 16, 2018. The environmental document is available for review during normal business hours at the City of Rocklin Community Development Department, Planning Division, located at 3970 Rocklin Road, Rocklin, CA 95677 and online at <u>http://www.rocklin.ca.us/depts/develop/planning/currentenvirondocs.asp</u>. <u>PROJECT DESCRIPTION</u>: This application is a request for approval of a Tentative Subdivision Map, General Development Plan Amendment, and Oak Tree Preservation Plan Permit to create 60 residential lots, 2 open space lots, 1 buffer lot, and 1 detention basin lot on approximately 25.5 total acres. The original Croftwood Unit #2 General Development Plan (PDG-93-01), Tentative Subdivision Map (SD-93-04) and Oak Tree Preservation Plan Permit (TRE-94-13) were approved by the City of Rocklin in 1994 for a 60-lot residential subdivision, but has since expired. This amendment would supersede all original approvals.

<u>PROJECT LOCATION</u>: The subject property is located on the west side of Barton Road at the terminus of Lakepointe Drive; approximately 0.8 miles north of Rocklin Road. APN 045-053-015.

The Mitigated Negative Declaration is being circulated for a 30-day public review period beginning December 14, 2017. Consequently, comments should be received by the City of Rocklin <u>NO LATER THAN 5:00 P.M. ON JANUARY 16, 2018.</u>
