We have had an eventful and busy year. We had some major cases this year and an uptick in



On the evening on November 30<sup>th</sup>, 2009 Officer Jeff Paxton was on patrol in the area of South Whitney and Five Star when he drove through the Willow Rock Plaza shopping center parking lot. While checking the back of the businesses he came across two individuals leaving their "tag" on a blank canvas, the old Food for Less building. Upon seeing Officer Paxton, both subjects fled on

foot with Paxton in pursuit. One subject fled over a fence and into the neighborhood while the other tried to hide behind a dumpster before being taken into custody. Weekday Graveyard Officers set up a perimeter but were unable to locate the second suspect.

Paxton Mirandized the subject he had in custody and got a

possible name of the second subject. Officer Krempin began a computer search for a similar named subject in Rocklin. In a short time, Krempin had a phone number and contacted with a family member, of the 2<sup>nd</sup> subject, who agreed to have him call the Police Department. True to his word, the subject called Krempin a short time later and confessed to the graffiti.

Located at the scene and on the first arrestee were numerous cans of spray paint, large marking pens and a "headlamp," to help them see what they were vandalizing. Had Officer Paxton not been diligently patrolling, these two subjects would have completed their murals and left the scene, likely to **'tag'** our City again.
