

TERMS AND CONDITIONS:

eTRAKiT allows applicants to apply for building permits, submit plans, pay fees, check on permits/project status, view and print building permits/plans, and schedule inspections.

In consideration of being authorized to use eTRAKiT, _____
(hereinafter referred to as the "licensee") understands and agrees to the following terms and conditions:

1. Only the licensee may obtain any type of building permit through eTRAKiT. The licensee will keep confidential and shall take all necessary steps to ensure that any passwords used to access eTRAKiT shall only be used by licensee and licensee shall be fully responsible for any use of the eTRAKiT system by persons using any password issued to licensee.
2. All work authorized by any permit must comply with all applicable ordinances and codes adopted by the City of Rocklin.
3. All work authorized by permit is subject to inspection. Required inspections can be scheduled by calling the Building Division's inspection line at (916) 625-5136 or via eTRAKiT. Access must be provided for inspection purposes.
4. Permits shall automatically EXPIRE and become void if work has not started within one year from the issuance date or if the work is suspended or abandoned for a period in excess of 180 days. An extension may be granted if requested in writing before permit expires.
5. "Simple Permits" (Residential only) are permits that do not require plan review by the City. If, subsequent to the issuance of a Simple Permit, the Building Official determines that plans or other review are required for the work undertaken, the permit may be suspended or revoked until such time as proper reviews and approvals are obtained.
6. The issuance of a Simple Permit (Residential Only) shall not serve to legalize other unauthorized construction, improper occupancies, additional dwelling units, or unauthorized lands uses not otherwise legally established. All simple Permits are subject to review and approval by the City of Rocklin Building Division.
7. Work shall not commence until the licensee is in receipt of an issued building permit.

8. The licensee must be properly licensed by the State Contractors Board to perform all work for which licensee obtains permits. All permits will be verified upon issuance. **Plumbing, mechanical, electrical and roofing permits issued to a B (General) License contractor will be void and ineligible for a refund.**
9. The licensee hereby certifies that all information provided herein is correct and that all information that licensee, or licensee's authorized agents, will provide through eTRAKiT will be correct.
10. Licensee shall abide by all the terms listed in the declaration on the building permit. Licensee or licensee's authorized agents must print, sign and post the permit and inspection record list at the job site.
11. The licensee's ability to continue using eTRAKiT shall be revoked if the licensee fails to adhere to any of the above noted terms or any City Codes or ordinances, or any State or Federal laws or regulations.
12. "Total fees due" refers to Building Division fees only. All other fees (i.e. sewer, water, school, fire, etc.) are paid separately.

USING ETRAKIT:

- To initiate the permit application or permit request in eTRAKiT, a valid address must be selected into eTRAKiT. If the licensee does not find the valid address, the licensee must contact the Building Division to correct discrepancies or assign an address.
- Upon renewal of the licensee's State Contractor's License and/or City of Rocklin Business License, the licensee must contact the Building Division to update your file. The licensee cannot obtain web permits if the licensee's State Contractor License or City of Rocklin Business License does not appear to be current in the City's tracking system.

ELIGIBLE ETRAKIT RESIDENTIAL SIMPLE PERMITS AVAILABLE:

Simple permits do not need to go through the permit request and electronic plan review process. Instead, applicants can apply and upload documents, pay fees, and have the permit issued electronically all through eTRAKiT for the following:

- Residential Water Heater Replacement (Up to 75 gallons gas storage)
- Residential Heating, Ventilation, or Air Conditioning Replacement (Like for Like)

ALL OTHER PERMIT APPLICATIONS SHALL BE SUBMITTED AS PERMIT REQUESTS ON ETRAKIT

- Permit requests allow staff to review the application and perform a completeness check prior to initiating the permit application and plan review.
