ROCKLIN FIRE

The Fire Department is dedicated to providing emergency response services across the City, working tirelessly to minimize injuries, prevent loss of life, protect property, and reduce environmental damage. Our mission is to enhance community safety, mitigate risks, and improve the overall quality of life by responding swiftly to emergencies, solving problems efficiently, and delivering compassionate service. Our department is organized into four divisions: Fire Administration, Field Operations, Fire Prevention, and Emergency Management. Together, we operate with a team of 44.5 full-time equivalent (FTE) staff, all committed to serving the community with professionalism, care, and dedication. Three fire stations house several pieces of fire apparatus currently in the City of Rocklin. All apparatus are utilized for both emergency and support operations. Each fire station staffs a primary fire apparatus with a Fire Captain, Fire Engineer, and a Firefighter.

Minimum daily staffing level includes:

- 1 Battalion Chief
- 3 Fire Captains
- 3 Fire Engineers
- 4 Firefighter-Paramedics

Operational personnel cover three shifts (A, B, and C Shift), working a 48/96 schedule, 7 days a week, 365 days a year in order to provide professional emergency response fire services to the Rocklin community.

We are looking for individuals who bring a strong combination of firefighting and advanced life support (ALS) knowledge. The ideal candidate:

- Licensed Paramedic or Lateral Firefighter/Paramedic
- Possesses a Proven Track Record: Demonstrates significant
 experience in fire suppression and/or emergency medical services,
 particularly at the Paramedic level, with a focus on providing highquality care in emergency situations.
- Is a Team Player: Values collaboration and excels in a team-based environment, working seamlessly with other fire, EMS, and public safety professionals to ensure the best outcomes in high-pressure situations.
- Is Physically and Mentally Prepared: Maintains a high level of physical fitness and mental resilience, able to effectively handle the physically demanding and stressful nature of the job, including responding to emergencies, operating heavy equipment, and performing rescues.
- Demonstrates Leadership and Initiative: Takes proactive steps to
 ensure safety, preparedness, and efficiency, both in emergency
 responses and routine station duties. Is willing to take on specialized
 roles and training opportunities to continue developing professionally.
- Is Committed to Public Service: Has a genuine passion for serving and protecting the community, with a strong understanding of fire prevention, public safety, and emergency response protocols.

- Adapts to Changing Situations: Is flexible and able to think critically in fast-changing environments, making sound decisions quickly while prioritizing the safety and well-being of those involved.

Non-lateral Firefighter Minimum Requirements

- Education and Experience:
 - Equivalent to graduation from high school.
 - Two years, full-time professional experience as an EMT or Paramedic.
- License and certificates:
 - A valid EMT certification or Paramedic license.
 (paramedic is preferred)
 - o California Firefighter I Certificate
 - A current Candidate Physical Ability Test (CPAT) card

Lateral Firefighter Minimum Requirements

- Education and Experience:
 - Equivalent to graduation from high school.
 - Current employment with an urban/suburban fire suppression agency with at least three (3) years of full-time, paid experience comparable to the City's classification of firefighter or higher rank.
- License and certificates
 - A valid EMT certification or Paramedic license.
 (paramedic is preferred)
 - o California Firefighter I Certificate

WHAT TO EXPECT

The recruitment will consist of a qualification screening, practical paramedic assessment, and oral panel interview. The paramedic assessment is scheduled for January 7 and 8, 2026. An eligibility list will be established and hiring interviews will be held tentatively the week of January 12, 2026. Selected candidates will be subject to a livescan clearance, medical screenings, which includes drug testing, a psychological examination, and a background clearance. Successful lateral candidates can expect to have an on-the-job training academy.
