PUBLIC HEARING NOTICE

NOTICE IS HEREBY GIVEN THAT THE CITY COUNCIL OF THE CITY OF ROCKLIN WILL HOLD A PUBLIC HEARING IN THE COUNCIL CHAMBERS AT THE ROCKLIN CITY HALL LOCATED AT 3970 ROCKLIN ROAD, ROCKLIN, 95677 (SECOND FLOOR) BEGINNING AT 6:00 P.M. ON TUESDAY, AUGUST 24, 2021, TO CONSIDER THE FOLLOWING:

RE: PUBLIC HEARING - GENERAL PLAN AMENDMENTS – 2021-2029 HOUSING ELEMENT AND 2021 SAFETY ELEMENT UPDATES

PROJECT DESCRIPTION/LOCATION - State law requires cities to update their General Plan Housing Element for the 2021 - 2029 planning period. The City of Rocklin has prepared a Draft Housing Element which includes an analysis required by State law related to: 1) existing demographics and housing characteristics; 2) market, government and environmental constraints; 3) land, financial and administrative resources available to meet housing demand; 4) accommodation of the City's Regional Housing Need Allocation; 5) establishment of goals and policies to address housing needs; and 6) a review of past accomplishments under the 2013 - 2021 Housing Element.

The City's General Plan Safety Element is also being updated concurrently to address climate adaptation and resiliency strategies and identify new information relating to flood and fire hazards in compliance with State law as updated by recent legislation.

Goals, policies and programs associated with these documents apply Citywide.

ENVIRONMENTAL DETERMINATION: An Environmental Impact Report for the City of Rocklin General Plan was approved by the City Council via Resolution No. 2012-170. The updates to the Housing and Safety Elements do not trigger the need for supplemental or subsequent review under Section 15162 of the CEQA Guidelines. Therefore, the City is proposing an Addendum to the General Plan EIR for these activities in compliance with Section 15164 of the California Environmental Quality Act (CEQA).

The Planning Commission reviewed this item on August 3, 2021 and voted 4-0, one vacancy, to recommend City Council approval of the project.
