# Message from the Chief by Mark Siemens

#### Team Building

As this issue goes to print, police supervisory staff members are attending a workshop to develop skills in creating stronger teams and more functional workplace relationships. In organizations we achieve things in spite of the individual frustrations and conflicts that build. In time, through trial and error, or by chance, some of us develop communication strategies that overcome the relational difficulties to varying degrees, but some do not.

Workplace relational issues have an impact on our capacity to perform individually and collectively. Workplace relationship quality is the most important factor to individual job satisfaction, especially when conflicts, whether real or perceived, are with your direct supervisor. We can systematically improve our relationships so why should we leave it to chance.

As an organization we are taking steps to employ a strategy in clearly defining and communicating expectations of each other. This process includes defining and clarifying the supervisor's expectations of direct reports, employee expectations of a supervisor and expectations of peer team members.

The second part of the strategy is to talk about how we will approach each other in the event a member does not meet an expectation. Having the discussion about these matters before the conflict arises is key to easing the stress and misperceptions that can surround such a conversation. Understanding each others expectations and improving communication will reduce conflict and improve the strength of each team. We can improve our relationships at work with a little effort. Your supervisors will be bringing the process to a briefing or team meeting near you, so tune in and expect results.

## Burglars Go To Jail, by Lt. Lon Milka

During the morning of January 7, an alert Rocklin citizen noticed a vehicle parked near her residence which was unfamiliar to the neighborhood. Inside the Dodge sedan was a suspicious acting female who was behind the wheel. Quite unexpectedly the car pulled into the garage of her neighbor's house and left a few minutes later. Rocklin police arrived at the 5800 block of Ford Road to find that the house had been burglarized. Stolen was over \$11,000 of computers and musical instruments. Fortunately, the alert neighbor was able to obtain the license plate number of the Dodge. The very next day, information provided by the citizen led Rocklin detectives to an active parolee who was located in Elk

Grove. Evidence found with the parolee led to his arrest and led detectives to an apartment in Sacramento. A probation search of the residence located stolen property and the four people inside, including two additional active parolees, who were arrested. Leads produced from the search of the apartment led to a search of a storage locker in Rio Linda. Inside the storage locker was stolen property from the Rocklin burglary as well as property from a Roseville theft that had occurred on January 7th. ### Disaster Avoided, By Lt. Lon Milka

Early on January 5, 2008, Rocklin Officers responded to the 3000 block of Twin Creeks Lane to investigate a hit-and-run vehicle accident. The caller said a male driver had collided with two parked cars and then fled. Officers found wrecked parked cars and then found an abandoned vehicle about ½ mile away at the intersection of Springview Drive and Sunset Blvd. A search of the immediate area for the driver proved fruitless. An investigation at the hit-and-run scene led to the name and description of the suspected driver, a 12 year old boy. According to witnesses, the Roseville boy snuck out of the house with his uncle's car keys while visiting relatives in Rocklin and drove away. About 30 minutes later searching officers located the boy just across the city line in Roseville. He displayed symptoms of alcohol intoxication and was arrested for driving under the influence of alcohol, hit & run, and driving without a driver's license. He was released to his mother and will face a review of the charges by the Placer County Probation Department and the D.A.'s Office. "Anytime you have a 12 year old behind the wheel of a

car, a disastrous event is more than likely to happen," said Lieutenant Lon Milka. "Anytime you have a 12 year old behind the wheel of a car who is intoxicated, a disastrous event is lucky to be avoided. In this case, we are all extremely lucky that a disaster did not occur and that no one was hurt."
