**NOTICE IS HEREBY GIVEN** that the Rocklin City Council will hold **FOUR (4)** public hearings on **TUESDAY, MAY 22, 2018**, at the hour of 6:00 P.M., in the Rocklin City Council Chambers, 3970 Rocklin Road, Rocklin, California, being the regular meeting place of said City Council.

The four public hearings listed below are for the hearing of protests or objections in reference to the levy of the proposed liens and assessments. Any interested person may appear at the hearing and protest the delinquent charges and/or assessments.

- 1. <u>Delinquent Refuse Collection Charges</u> to consider the imposition of liens on certain parcels of property within the City of Rocklin because of delinquent refuse collection charges for parcels that have remained unpaid for at least 180 days.
- 2. <u>Delinquent Nuisance Abatement Charges (Weed Abatement)</u> to consider the imposition of liens on certain parcels of property within the City of Rocklin for costs related to abatements of nuisance (weed abatement) at the public expense during the summer of 2017.
- 3. <u>Levy and Collect Annual Assessments for Lighting Maintenance District No. 1</u> to levy and collect annual assessments for the continual maintenance of street lighting and traffic signals for fiscal year 2018-2019.
- 4. <u>Levy and Collect Annual Assessments for Landscaping and Lighting Maintenance District No 2</u> to levy and collect annual assessments for the continual maintenance of street lighting and landscaping for fiscal year 2018-2019.

Pursuant to the Landscaping and Lighting Act of 1972, the Rocklin City Council was presented with and has approved the Engineer's Reports on the levy of the annual assessment for both Lighting Districts for fiscal year 2018-2019. Copies of the reports are on file for public inspection and copying for the cost of duplication at the office of the City Clerk, located at City Hall, 3980 Rocklin Road, Rocklin, California, between the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday, exclusive of holidays.

Interested persons may submit written comments addressed to the City Clerk, 3970 Rocklin Road, Rocklin, California 95677, prior to the hour of 5:00 p.m. on Tuesday, May 22, 2018.

Court challenges to any public hearing items may be limited to only those issues which are raised at the public hearing described in this notice or in written correspondence delivered to the City Clerk at or prior to the public hearing. (Government Code Section 65009).
