NOTICE IS HEREBY GIVEN by the City of Rocklin (the "City") with respect to its Community Facilities District No. 1 (the "CFD") that on February 13, 2024, the City Council of the City, as the legislative body for the CFD, adopted its Resolution No. 2024-042, "Resolution of the City Council of the City of Rocklin of Intention to Annex Territory to Rocklin Community Facilities District No. 1 (Annexation No. 89) and to Authorize the Levy of Special Taxes Therein (Stanford Plaza Chipotle, APN 364-090-025-000)" (the "Resolution of Intention"). Reference is hereby made to the Resolution of Intention, on file with the City Clerk of the City for further particulars. The following is a summary of the provisions of the Resolution of Intention.

The Resolution of Intention provides that the special taxes heretofore caused to be levied in the CFD for financing the public facilities and/or services provided through the CFD shall be levied in the territory proposed to be annexed, subject to public hearing and landowner election proceedings as specified in the Act.

Notice is further given that TUESDAY, MARCH 26, 2024, at the hour of 6:00 p.m., in the City of Rocklin City Council Chambers, 3970 Rocklin Road, Rocklin, California, are the time and place when and where the Council of the City as the legislative body for the CFD, will conduct a public hearing on the annexation of the territory described in the Resolution of Intention to the CFD and finally consider and determine whether the public convenience and necessity require the annexation of said territory to the CFD and the levy of special taxes therein.
