# Residential Re-Pipe/Water Main Submittal Checklist

A plumbing permit is required to re-pipe the water service, and or the interior water piping system. Plans are generally not required to re-pipe a single-family dwelling unless it is determined that they are necessary. City of Rocklin is currently using the 2022 California Plumbing Code (CPC).
