(ENV2026-0001) OF ENVIRONMENTAL IMPACTS FOR THE SUNSET WHITNEY RECREATION AREA  
(SWRA) MASTER PLAN

**REVIEW PERIOD: January 23, 2026 to February 23, 2026**

**PROJECT DESCRIPTION:** The SWRA Master Plan Project entails the conversion of a defunct private golf course into a public recreation area, utilizing to the extent possible the conversion and enhancement of existing improvements such as using former paved cart paths and bridges for paths and trails. The recreation area is anticipated to include numerous improvements and amenities such as, but not limited to, pickleball courts, a veteran's memorial area, a multi-use building, active playground and play structure areas, and picnic areas, using a phased approach.

**PROJECT LOCATION:** The former Sunset Whitney Golf Course site (4201 Midas Avenue), generally located to the east of Sunset Boulevard, to the south of Midas Avenue and to the west of 5<sup>th</sup> Street, in the City of Rocklin. The Assessor's Parcel Numbers are 010-010-011, 010-010-014, 010-040-007, 010-040-008, 016-010-005, 016-010-006, 016-010-007, 016-020-003, 016-020-004, and 030-140-009.

**PROPOSER:** City of Rocklin

The review period for the Mitigated Negative Declaration begins on **January 23, 2026** and ends at **4:00 p.m. on February 23, 2026**.
