**Whitney Ranch Trunk Sewer Project Fee** - The purpose of the Whitney Ranch Trunk Sewer Project Fee is to further the General Plan goal “to ensure that adequate public services and facilities are provided to meet the needs of residents of the City” by providing another funding source from new development for capital improvements to serve new development. Fees collected shall be used to finance only the Phase II Whitney Ranch Offsite Sewer Trunk line.
